



Announcement of Mahidol University

On

Guidelines for Operations under the State of Emergency Announcement

Reference is made to the release of the Thai government's State of Emergency Announcement and the provisions under Section 9 of the Emergency Decree on Public Administration in Emergency Situation B.E. 2548 (No. 27) dated the 10th July 2021, Mahidol University would like to announce guidelines for operations as follows:

1. All heads of faculties/colleges/institutes in Phyathai, Bangkok Noi and Salaya Campus and vice presidents responsible for units and divisions in the Office of the President are to advise staff members and students residing in or having to commute through the 6 highest maximum controlled areas (Bangkok metropolitan area and its adjacent provinces), including Bangkok, Nonthaburi, Pathum Thani, Nakhon Pathom, Samut Prakarn and Samut Sakorn, to work from home and participate in teaching and learning through the online systems. Only if necessary, some staff members may be authorized, e. g. those in healthcare services, vaccination sites and security units, so on and so forth.
2. All faculties/ colleges/ institutes in every campus are to follow Mahidol University's Guideline for Undergraduate Teaching and Learning (Academic Year 2564) dated the 23rd June 2021. Heads of faculties/ colleges/ institutes are authorized to offer online teaching and learning, assessments and other academic activities through online systems as seen appropriate.
3. All faculties/ colleges/ institutes in Phyathai, Bangkok Noi and Salaya campuses are encouraged to cancel or postpone social functions and other activities with participants more than 5 people, except those religious and traditional ceremonies. All measures relating to the prevention of the outbreak of the Coronavirus 2019 (COVID – 19) must also be strictly observed in all these events and ceremonies. Faculties/ colleges/ institutes in

Phyathai, Bangkok Noi and Salaya campus planning to use the premises for activities with participants more than 5 people, a permission from their respective local authorities is required. Faculties/colleges/institutes in Salaya campus are to conduct an online self-assessment via the Thai Stop Covid+ in order to report to the Committee for Disease Control of Nakhon Pathom Province for consideration.

4. In accordance with the Announcement of Bangkok Metropolitan Area on the Temporary Closure of Premises (No. 35) dated the 5th July 2021 and the Announcement of Nakhon Pathom Province on the Relaxing Measures to Prevent the Outbreak of the COVID-19 Among Construction Workforce in Nakhon Pathom Province (No. 75/2564) dated the 5th July 2021, faculties/colleges/institutes in Phyathai, Bangkok Noi and Salaya campus are allowed to continue on with some construction operations. These constructions include, for example, the projects which cannot be postponed or delayed due to its effects on the long-term infrastructure of the site or the probability of endangering the public, projects relating to the traffic and road safety, projects relating to the prevention of the COVID-19 or those relating to public health measures. Faculties/colleges/institutes are advised to apply for a permission to their respective local authorities at the Department of Public Work, Bangkok Metropolitan Area (for Phyathai and Bangkok Noi Campus) and the Committee for Disease Control of Nakhon Pathom Province (for Salaya Campus).

Please be advised accordingly. This announcement enters into effect from the 12th July 2021 onwards until further notice.
