**Subject: Announcement of Publishing Review Articles Awards for Graduate Students  
for the Fiscal Year 2025**

The Faculty of Graduate Studies has a policy to support the publication of review articles in the form of Narrative review, Systematic review, Systematic review and Meta-analysis by graduate students of Mahidol University. This is aimed at training students to write internationally recognized academic articles, increasing the citation rate for Mahidol University and enhancing students' competency to graduate more quickly. Therefore, the Faculty of Graduate Studies intends to offer awards to graduate students for publishing review articles for the fiscal year 2025.

### **1. Objectives**

- 1.1 To promote the publication of review articles in the form of Narrative review, Systematic review, and Systematic review and Meta-analysis by graduate students
- 1.2 To increase the number of published works and citations for Mahidol University
- 1.3 To encourage students to complete their studies more quickly

### **2. Eligibility for Submitting a Request for the Award for Publishing Review Articles by Graduate Students**

- 2.1 The applicant must be a graduate student at Mahidol University.
- 2.2 The content of the work must be related to the student's thesis, with the student's name listed first and the thesis advisor as the corresponding author.
- 2.3 The work submitted for the award must be in the form of a Narrative review, Systematic review, or Systematic review and Meta-analysis.
- 2.4 The applicant must have obtained approval from the thesis advisor (corresponding author) as specified in the form.
- 2.5 The work must have been published in a journal and must be searchable in that journal.
- 2.6 The article must specify the student's affiliation to Mahidol University. If the article is listed in the Scopus database, it must include the keyword "Mahidol University" for searchability.
- 2.7 The work submitted for the award must be published in a journal indexed in the Scimago Journal & Country Rank (SJR) database and must be in an international journal listed in Quartile 1 or 2 of the global database.

### 3. Award Amount

3.1 The award of 10,000 THB:

- The Students must provide proof of completion of the Faculty of Graduate Studies support processes, such as attending workshops organized by the Faculty of Graduate Studies, for example, the MUGR Workshop: Systematic Review and Meta-Analysis, or learning how to write Review Articles through the MUCE (Mahidol University Continuing Education).

- The student must acknowledge the Faculty of Graduate Studies, Mahidol University, by specifying "This work partially supported by Faculty of Graduate Studies, Mahidol University" in the Acknowledgement section of the published work.

3.2 The award of 5,000 THB:

- The student must acknowledge the Faculty of Graduate Studies, Mahidol University, by specifying "This work partially supported by Faculty of Graduate Studies, Mahidol University" in the Acknowledgement section of the published work.

### 4. Schedule and Supporting Documents to Apply for the Award

4.1 The Faculty of Graduate Studies requires graduate students to apply for the publishing award via the online system within the specified period set by the Faculty of Graduate Studies only.

4.2. Regarding the required supporting documents for the award consideration, students must fill out the online application form for the award for publishing review articles, accessible at <https://graduate.mahidol.ac.th/tnai/?p=scholarship>. Applicants must attach the following documents:

- A file of the published work
- Proof of publication acceptance from the journal
- Evidence of participation assisted by the Faculty of Graduate Studies (in the case of applying for the award as per Section 3.1), such as an evidence of attending of Research Clinic or an evidence of learning from MUCE (Mahidol University Continuing Education)

## 5. Awarding Criteria

5.1 The qualifications of eligible candidates shall be in accordance with the conditions specified in Section 2.

5.2 The decision of the Faculty of Graduate Studies is final and shall not be subject to any appeal.

6. The practices and conditions not included in this announcement will be dealt with accordingly at the discretion of the Dean of the Faculty of Graduate Studies on a case-by-case basis.
