1. Education Services Fee (Tuition Fee for maintaining student status)	
1.1 First semester	7,200 baht
1.2 Second semester	5,800 baht
2. Health Insurance (Additional Fee for Non-Thai Students)	3,500 baht/year
3. International Program and International Program-Special	
3.1 Graduate Tuition Fee	9,000 baht/credit
For students who do not receive any scholarships or receive a scholarship that only covers part of the graduate tuition fee, the program and the Faculty of Graduate Studies may consider to reduce the graduate tuition fee for the students. Nevertheless, the amount of graduate tuition fee must be no less than 1,800 baht/credit after the reduction.	
3.2 Thesis Registration Fee	
Master's Thesis Registration Fee (Plan A1)	90,000 baht/thesis
Master's Thesis Registration Fee (Plan A2)	30,000 baht/thesis
Doctoral Thesis Registration Fee 36 credits	90,000 baht/thesis
Doctoral Thesis Registration Fee 48 credits	120,000 baht/thesis
The thesis registration fee can be paid in two equal installments, at the first semester and the second semester of thesis registration.	
3.3 Research Supplies Fee	
Master's degree Program	150,000 baht
Doctoral degree Program	300,000 baht
This fee must be paid along with the "Thesis Registration Fee/Thematic Paper Registration Fee".	
Students who are assigned to pay at the standard rate of the "Research Supplies Fee / Thematic Paper Supplies Fee" may request to separate the entire fee into 2 installments to pay in the first and the second semester of their thesis/thematic registration.

Students who do not receive any scholarships or receive a scholarship that only covers part of the “Research Supplies Fee / Thematic Paper Supplies Fee”, the program and the Faculty of Graduate Studies may consider to reduce or waive the “Research Supplies Fee / Thematic Paper Supplies Fee” for the students based on a case-by-case basis.	
3.4 Thematic Paper Registration Fee (Plan B)	15,000 baht/thematic paper
3.5 Thematic Paper Supplies Fee Master of Science Program in Regulatory Sciences for Pharmaceutical and Health Products	50,000 baht
